# RESTRICTIONS

## RESTRICTIONS

- **Golf Cart Rental** - Each pass holder is entitled to the use of our golf cart fleet at Fraser Edmundston Golf Club. In purchasing a pass, each passholder agrees to pay for any and all damages to the golf cart while in said passholder's possession. Failure to do so will result in the suspension of the season pass and its privileges.
- **Annual Couples Pass** – In order to qualify for this annual season pass rate, the couple must reside at the same address.
- **Outside Alcohol** – NB liquor laws clearly state that no outside alcohol be brought onto the property. Bringing outside alcohol onto the property will result in the suspension and/or loss of privileges.
- **Payment Plan** – Failure to comply with the payments schedule will result in the suspension and/or loss of privileges until the balance is paid in full.
- **Daily Limits** – Passholders may book a maximum of one tee time per day. Additional tee times will be available on a walk-on basis.
- **Access** – Fraser Edmundston Golf Club reserves the right to close the course and/or clubhouse to accommodate private functions.
- **Liability** – Fraser Edmundston Golf Club assumes no responsibility for any individual property damage, loss or bodily injuries incurred while at the club.
- **Refunds** – Any refund, credit or portion thereof is at the discretion of the general manager and will only be issued with a documented medical reason.
- **Booking Process** – Passholders may book seven days in advance starting at 7:00AM through our online looking engine, or by calling the Golf Shop, or in person. All bookings must include all player's names.
- **Cancellation Policy** – All cancellations must be made with at least 24-hour's notice. In the case of no-shows, Fraser Edmundston Golf Club reserves the right to charge a cancellation fee to the individual or to suspend booking privileges.
